1. Minutes of June 18, 2015

There was some discussion concerning a possible spelling error and the way a motion was made. A. Fire Chief's report:

1. Final costs of Medic 11's repair

Chief Hunt mentioned that we have not received an invoice yet on Medic-11 repairs so we don't have a final cost yet. Chief Hunt also mentioned that Medic-11 still isn't right.

He took it back yesterday (7-15-2015) because it was running rough and found out that it it had blown a hose. That was repaired and ran great until he got back into the warmer weather and it started doing the same thing and was only able to go 50 MPH maximum. It also has no error codes so the shop is doing some research on it.

2. Wildland update.

Chief Hunt mentioned that he had completed another refresher course and we've got 2 more personnel we can use. Also the type 3 engine just got back after spending 16 days in No. California. Board Chairman Reber asked what was going on with E-11. Chief Hunt mentioned that a seal was leaking and while they were at it they also put spray bars on T-21. Chief Hunt mentioned that it would help in getting it out more and also be held over after the fact for wetting down the roads and other areas during overhaul of the fire area.

- B. Monthly Fire and EMS Reports for the month of:
 - 1. June 2015

Captain Jackson gave the fire and EMS report. We had a total of 11 Fire incidents and 43 EMS responses for a total of 54 incidents for the month of June 2015.
