## **MINUTES OF APRIL 16, 2020**

#### 1. CALL TO ORDER:

Board Chairman Adriance brought the meeting to order at 6:02 P.M. on APRIL 16, 2020. Following COVID-19 precautionary measures, the board members and general public were encourage to call into a teleconference at 1(928) 990-5192, access code 1912735. Those attending in person were expected to follow all applicable federal, state and county mitigation guidelines.

# 6. REPORTS AND CORRESPONDENCE:

- a. Fire Chief's Report:
  - i. Discussion and possible action re: AFG FEMA grant update

Discussion only.

Chief Hunt reported that the AFG FEMA grant request has been submitted and accepted (# assigned).

He was concerned that the financial issues related to the COVID-19 pandemic may affect the grant's availability. However, he was able to confirm that the grant is still being processed.

Chief Hunt reported that additional AFG grants for PPE are available. However, our current needs are being met, so he will not be pursuing any of these.

ii. VFA grant update

Discussion only.

Chief Hunt reported that this grant request is still pending. No word to date on this grant. Discussion only.

b. Fire and EMS Report for the month of: March 2020 Chief Hunt gave the Fire & EMS report - There were 14 Fire Calls and 65 EMS Calls for a total of 79 Fire and EMS Calls for the month of March 2020. For 2020 YTD there were a total of 42 Fire Calls and 215 EMS Calls for a total of 257 Fire and EMS Calls.

c. Board of Directors Report: COVID-9 situational awareness Board Chairman Adriance reported that he is hearing a lot of positive comments from the community regarding the service that the fire district is providing. He reported that there are no known positive COVID-19 cases reported in our district boundaries at this time. We are applying all government recommended COVID-19 response protocols. Chief Hunt commended the Board Members for applying the COVID-19 precautions to our board meeting which sets a good example for the public.

Finance Director Arnett presented the Board Members with a calendar showing the FY 2020/21 budget approval and submission timeline. A special budget work meeting will be scheduled on May 14, 2020 to give the board members an opportunity to discuss each of the line items on the budget.

b. Discussion and possible action re: Economic Task Force Identifying Funding Opportunities for Fire Districts

Finance Director Arnett presented the Board Members with information regarding the CARES Act Provider Relief Fund from the U.S. Department of Health and Human Services which fire districts qualify for. She reported that the fire district will be receiving an estimated payment of \$6,086.40 based on the applicable formula. She also reported that low interest loans are available.

c. Discussion and possible action re: Resolution calling election at the Board Meeting on May 21, 2020 Discussion only.

Administrative Assistant Sparks reported that at the next regular Board Meeting on May 21, 2020 the Board Members would need to discuss and take possible action re: a resolution calling election to fill 2 seats on the Board. The Board Members were given a calendar showing the election time line.

d. Discussion and possible action re: Invoice from WR Whittington Discussion only.

Finance Director Arnett explained the charges received from WR Whittington dated February 18, 2020. The \$17.50 bill (.10 of an hour at \$175.00 per hour) was for a voice mail phone message that was left on the fire district's main phone number by the office of Mr. Whittington. No one spoke to Mr. Whittington's office on this date.
