# MINUTES OF MAY 20, 2021

# 1. CALL TO ORDER:

Chief Hunt reported that he has no new information on the AFG Grant.

b. Fire and EMS Report for the month of: April 2021

Chief Hunt gave the Fire & EMS report - There were 20 Fire Calls and 66 EMS Calls for a total of 86 Fire and EMS Calls for the month of April 2021. For 2021 YTD there were a total of 56 Fire Calls and 295 EMS Calls for a total of 351 total incidents.

c. Board of Directors Report: Job well done on several recent high profile incidents.

## 7. OLD BUSINESS: ACTION/DISCUSSION

There were no items of "old business" for discussion or action at this meeting.

#### 8. NEW BUSINESS: ACTION/DISCUSSION

- a. Discussion and possible action re: Resolution 2021-10 Stop Burning Order Chief Hunt recommended that the Board issue a stop burning order effective on May 21, 2021 at 6:00 A.M. Arizona time due to the current high fire danger going into summer. Board Chairman Adriance made a motion to accept Resolution 2021-10 Stop Burning Order. Board Clerk Oliver seconded the motion. Motion passed to accept Resolution 2021-10 Stop Burning Order. 4-0-1
- b. Discussion and possible action re: May 7, 2021 incident involving Engine 11 Discussion only.

The Board members were given a copy of the Arizona Crash Report Narrative received from the Mohave County Sheriff's Department. The narrative indicated that the driver that hit engine 11 was at fault.

Board Chairman Adriance indicated that he had consulted with legal counsel WR Whittington regarding the incident. It was recommended that the Fire District request a full investigation of the incident from the Insurance Adjuster. It was also recommended that all Fire District personnel on the scene provide a detailed statement of what they observed.

Board Clerk Oliver suggested that the Fire District look into the possibility of installing front and rear cameras on the District vehicles and the policies involved.

The Board members were provided with a copy of the Fire District's Drug and Alcohol Testing guidelines from the HR Policy Manual. It was suggested that the Fire District look into revising the post-accident/incident drug and alcohol testing guidelines to make testing mandatory following any on-the-job accident or work related incidents where drug/alcohol use could be a contributing factor.

c. Discussion and possible action re: BDLFD HR Policy – Use of District Issued Vehicles
Finance Director Arnett asked the Board to consider changing the driver's license policy from
 Arizona only to include all valid driver's licenses. Based on the discussion of the May 7, 2021
 incident involving Engine 11, the Board ask the Fire District to look into revising the BDLFD HR Policy
 – Use of District Issued Vehicles policy to address post-accident/incident investigations and
 personnel providing statements.

Board Chairman Adriance made a motion to revise the BDLFD HR Policy – Use of District Issued Vehicles policy from Arizona only to include all valid driver's licenses.
